


3-Way Divert Valve, Chromatography Valve, and Crossover Valve

"I need fourteen valves to fit in a small space - some vertical with bottom outlets, some vertical with top outlets, some horizontal, various weir sizes, and a couple additional outlets for good measure."

This request came to ITT Pure-Flo from a BioPharm OEM designing a system that would be located in a small confined space. Therefore, they needed all the above requirements in minimal dimensions. The customer had considered welding all the valves in series. However when all the dimen-

sions were added up the overall length of the assembly created problems. More importantly the significant hold up volume was unacceptable.

Working in tandem with the OEM engineers, ITT Pure-Flo developed a design that addressed all the concerns surrounding the valve. The final design resulted in two machined blocks replacing the original fourteen valves. This significantly reduced dead-leg and hold-up volume and reduced the overall length of the assembly by 50 percent!




